Fixed fee to begin the certification process (not for companies that are already certified by ICEA in compliance with Reg. (EEC) No. 2092/91)	€ 400.00
Annual fee for the operator that is a processing firm (including documentation control)	€ 300.00
Fee for each non-farmer involved in the production chain or Farms that also have processing units (farmers with a turnover lower than € 40,000.00)	€ 200.00
Fee for farms and/or livestock farms supplying the vegetables or animal raw materials	€ 100.00
Inspections to be added to the normal control plan (including preevaluation visits)	€ 200.00 per inspection

TERMS AND METHODS OF PAYMENTS

- **THE FIXED FEES ARE REQUESTED WITHIN 15 DAYS FROM THE SUBMISSION OF THE CERTIFICATION REQUEST (IN THE STARTING PHASE) OR BY 31 FEBRUARY OF EACH YEAR (IN THE SURVEILLANCE PHASE.).**
- **THE VARIABLE FEE IS REQUIRED EVERY SIX MONTHS OR EACH YEAR ACCORDING TO ICEA REQUIREMENTS.**

PAYMENTS MUST BE MADE TO ICEA ISTITUTO PER LA CERTIFICAZIONE ETICA ED AMBIENTALE - STRADA MAGGIORE 29 BOLOGNA (ITALY), IN THE MANNER INDICATED BY ICEA ITSELF.
