### TERMS OF PAYMENT

#### ***Within the 28th of February of each year***

- Annual flat rate
- Any pending amounts (e.g. document verification, inspection reimbursements, tests, etc.)

#### ***Within the 31st of July of each year***

- Annual inspection visit, on account if still not accomplished
- Account Annual variable rate (€ 200)
- Any pending amounts (e.g. document verification, inspection reimbursements, tests, etc.)

#### ***Within the 31st of October of each year***

- Balance Annual variable rate (calculation based on the previous year turnover)
- Annual inspection visit, on account if still not accomplished
- Any pending amounts (e.g. document verification, inspection reimbursements, tests, etc.)
- Possible discounts for the use of the certified email account and web software.

#### ***Within the 31st of January of each year***

- Any pending amounts (e.g. document verification, inspection reimbursements, tests, etc.)
- Annual inspection visit, on account if accomplished
- Possible discounts for inspection visits at certified ICEA third parties clients

Initially (first year), the Annual flat rate (referred to the length of the contract, starting from the date on the Request form) will be invoiced right after the presentation of the signed List of fees and Request form. The document verification and all the other activities will be invoiced following the above mentioned deadlines.

**Before the emission of the conformity certificate** all the previous entries, including the costs of the first inspection visit, will have to be paid.

Invoices for tests at ICEA-qualified laboratories will cover all costs incurred (purchase of samples included). All costs will be communicated in advance to the operator, for approval. On completion of the tests, payment will be made against pro-forma invoice. After the payment has been made, a regular invoice will be issued.

**The controlled company is obliged to communicate the financial turn over within the given deadlines, and anyway not after the 1<sup>st</sup> October of each year. When the company does not inform ICEA of its turnover at the scheduled deadline, ICEA will apply the maximum variable rate of € 10,000.**

**THE PAYMENT WILL HAVE TO BE MADE AT ICEA ISTITUTO PER LA CERTIFICAZIONE ETICA ED AMBIENTALE – VIA NAZARIO SAURO, 2 – BOLOGNA - ITALY AGAINST A 30-DAY BANK RECEIPT (THE OPERATOR MUST COMMUNICATE IN ADVANCE THE RELEVANT BANK DATA TO ICEA).**

### **PARTICULAR CASES AND DISCOUNTS**

In the cases where certification is requested by operators characterized by particular logistic situations, ICEA reserves the possibility to apply special rates covering the costs of a specific inspection plan that will be defined on the basis of the following significant data:

- a) number of inspections that will be required in addition to the ordinary inspection plan,
- b) logistic and organizational details related to travel, sample collection and testing,
- c) number of samples and tests that will be required in addition to the ordinary inspection plan,
- d) number of products and production processes involved.

The companies acting on behalf of a third party won't need to pay the annual variable rate and it will be possible to define special conditions, based on the number of references and productive processes.

To the companies client of ICEA certified third parties it will be applied a **discount of € 100** on the price of the inspection visit.

**Discount of € 70** to all the operators using regularly and efficiently the software web for the verification and updating of the data and list/INCI products requested for the certification.
